Somos familiares residentes en Suecia del Dr. Abimael Guzmán Reinoso y nos dirigimos a Uds. Para exponer lo siguiente:

El Dr. Guzmán se encuentra en una prisión militar de la Base Naval del Perú desde 1992, hace más de 28 años, en aislamiento absoluto y condiciones inhumanas, penal que ha sido calificado por la ONU como un penal de tortura.

El Dr. Guzmán tiene 85 años de edad y sufre de un continuo deterioro de su precaria salud agravado por una aguda hipertensión arterial que padece y que pone en gravísimo riesgo su vida en caso de contraer el virus del covid-19 en la actual situación de pandemia mundial, la que se extiende también rápidamente en el Perú.

Los abogados del Dr. Guzmán presentaron ante las autoridades peruanas una solicitud de habeas corpus para que el Dr. Guzmán, en consideración del grave peligro en que se encuentra, cumpla su condena bajo detención domiciliaria. Dicho Habeas corpus fue rechazado sin razón ni investigación alguna por las autoridades y no han dado ninguna respuesta a la apelación que sobre esta negación se ha hecho. Tales hechos constituyen una abierta discriminación por razones políticas, violación completa del derecho al debido proceso judicial y una flagrante amenaza a la vida y salud del Dr. Guzmán.

Por las razones arriba expuestas y sumamente angustiados por las fatales consecuencias que puedan provocarse contra la vida y salud de nuestro familiar, nos dirigimos a uds. para denunciar estos hechos y solicitamos su intercesión ante las autoridades peruanas con el fin de que al Dr. Abimael Guzmán Reinoso se le permita cumplir su condena en detención domiciliaria.
